**SOLAR LEASE**  
**2024/2025**

Spring has arrived and it is time to welcome you to **White River Solar**. This is the sixth year for White River Solar and the program details have not changed. The White River Solar lease program allows members to lease “Blocks” of solar power per electric meter for a prepaid annual lease fee which results in a monthly production credit. WREA has made additional blocks available in 2024/2025 if existing lessees wish to expand their lease subject to the program details and new members may join the leasing program. Please see attached for program details.

Members interested in a solar lease should complete the following steps:

1. Determine the best leasing option by determining the meter and associated solar block tier that works best for you. Call WREA if you have questions about your lease options. Each meter must have its own lease.
2. Then, review the lease, sign where indicated and return to WREA by mail at **PO Box 958, Meeker, CO 81641** or by emailing a **signed form to customerservice@wrea.org** by **Monday, May 6, 2024**. Please note that WREA must receive a signed lease to be enrolled in the 2024/2025 White River Solar program. The lease fee will be automatically charged to your May bill. **Please DO NOT send a separate solar lease fee check with the submission of this form.**

The 2024/2025 prepaid annual solar lease fee will be automatically applied to your May 2024 electric bill and must be paid in full by June 15, 2024. Please note that the annual prepaid lease fee is non-refundable. The first 2024/2025 solar production credit will be applied to your June 2024 electric bill and remains \$5.00 per solar block. Enclosed you will also find general information about White River Solar.

The undersigned WREA Member hereby requests to lease solar blocks from White River Solar for the meter and tier specified above and pursuant to the lease terms and conditions set forth herein. The solar block lease shall be for a one-year term with the option to renew in 2025 upon payment of the annual lease fee and execution of the 2025 renewal form.

The undersigned member agrees for WREA to add the above elected 2024/2025 Solar Block Lease payment (\$36.00 per block) to its May 2024 electric bill. Member agrees to pay the elected solar block lease fee on or before June 15, 2024. If member fails to pay its May bill, including the solar fee when due, then member forfeits the solar lease. Forfeited solar panels will be made available to other WREA members for lease. The annual lease fee is non-refundable. Leases are not transferable nor assignable. **Signed leases must be returned to WREA by Monday, May 6, 2024.** A separate lease form is required for each electric meter.
