8. I am not in any way employed by or financially interested in a competing enterprise or a business selling electric energy to WREA.
9. I do not otherwise possess a substantial conflict of interest with WREA or its subsidiary WRE.
10. I do not hold an elective public office position in connection with which a salary is paid.
11. I agree to comply with and be bound by WREA's Articles of Incorporation, Bylaws, the membership application, and such rules, policies, tariffs, etc., as the WREA Board may adopt from time to time.
12. I have submitted at least fifteen (15) nominating petitions by qualified members of WREA, which designate my name, the term, and the district for which I am nominated, no later than 60 days prior to the date of the election.

⁴ A "close relative" means a child, stepchild, parent, stepparent, sibling, stepbrother, stepsister, grandchild, grandparent, mother-in-law, father-in-law, son-in-law, daughter-in-law, sister-in-law, brother-in-law, or any person residing in the General Manager's, employee's, or Director's household.
